Upon signing up for water service, you must contact the local Department of Environmental Quality (DEQ) office in Durant.

In order to get on schedule for a meter to be set, you must have one of the following:

- DEQ Final Inspection
- DEQ Permit to construct septic (Along with permission from DEQ, Derrick Kinard)
- Have an existing system
- DEQ approval for a pasture tap (for watering purposes only)

**MEMBERSHIPS ARE \$2500.00. ONE MEMBERSHIP, ONE METER.
EACH DWELLING, BUSINESS, OR TRAILER MUST HAVE A SEPARATE MEMBERSHIP.**

METERS WILL BE FURNISHED BY AND REMAIN THE PROPERTY OF THE DISTRICT.

BEFORE A WATER METER CAN BE INSTALLED, WE MUST HAVE THE AUTHORIZATION TO CONSTRUCT AN ON-SITE SEWAGE TREATMENT SYSTEM.
(DEQ PERMIT)

ALL WATER USED WILL BE BILLED BY THE FOLLOWING:

0 GALLONS – 2000 GALLONS \$20.00 MINIMUM CHARGE
NEXT 1000 GALLONS FOR \$6.00 PER 1000 GALLONS
NEXT 1000 GALLONS FOR \$7.00 PER 1000 GALLONS
NEXT 1000 GALLONS FOR \$8.00 PER 1000 GALLONS
NEXT 5000 GALLONS FOR \$9.00 PER 1000 GALLONS
OVER 10,000 GALLONS FOR \$12.00 PER 1000 GALLONS

ALL MEMBERS AND/ OR USERS MUST PAY A MINIMUM BILL USING WATER OR NOT.

ALL BILLS NOT PAID BY THE 15TH OF EACH MONTH WILL PAY AN ADDITIONAL 15% LATE CHARGE.

ANY BILLS NOT PAID BY THE 25TH OF THE FIRST MONTH DELINQUENT WILL BE DISCONNECTED. TO HAVE SERVICE RECONNECTED A FEE OF \$50.00 PLUS PAST DUE BILL MUST BE PAID.

BECAUSE YOU ARE RESPONSIBLE FOR THE METERED WATER, WE ASK THAT YOU KEEP THE METER BOX LID IN PLACE. ANYTIME YOU PLAN TO BE AWAY FOR AN EXTENDED PERIOD OF TIME WE SUGGEST YOU TURN YOUR WATER METER OFF. ALSO, IF YOU PLAN TO WINTERIZE YOUR HOME FOR THE SEASON OR NEED TO TURN THE WATER OFF AND ON, ON A REGULAR BASIS WE SUGGEST THAT YOU INSTALL YOUR OWN SEPARATE SHUT-OFF VALVE.

IF YOU SHOULD DISCOVER A BREAK IN A WATER MAIN OR DAMAGE TO THE LINE, PLEASE CONTACT THE OFFICE SO REPAIRS CAN BE MADE AS QUICKLY AS POSSIBLE. IF THE WATER SERVICE IS INTERRUPTED, WE ADVISE YOU TO TURN OFF AN ELECTRIC WATER HEATER.

THE DISTRICT IS ONLY RESPONSIBLE FOR SERVICE UP TO THE METER.
